Dear Headteacher,

We are awaiting the formal announcement from Government on 'Living with COVID' on Monday 21st February but would like to share some thoughts with you on what may happen over the next few months.

COVID rates in the city appear to be falling although, as we have noted before, probably not as sharply as our reported data. We anticipate, as we move towards the Spring, that rates will continue to fall, however we believe there may be a change in testing advice from next week and so our understanding of the local picture will be less clear. National modelling indicates we expect to see a decrease in cases through to the summer, with an increase in cases again over next winter; the size of these peaks and troughs is unknown. In addition, we know that there will be a further variant, perhaps several, over the next few years. Variants will appear unpredictably, not necessarily cause less severe disease and may or may not escape existing vaccines.

We are moving to a new phase of the pandemic, where testing and the response to COVID will be focussed on the most vulnerable, where we manage COVID within school settings as we would any other infectious disease. We can also expect a resurgence of our 'usual' infections as we are already seeing an increase in Chicken Pox cases and anticipate the emergence of Scarlet Fever soon.

It is important to remember, whether included in national guidance or not, that there are simple measures that we can continue to use within school settings to reduce the risk of the spread of infectious diseases. As we will no longer understand asymptomatic spread the possibility of undiagnosed cases within settings is significantly increased.

We would advise considering:

- Reminding parents that children should be kept at home if they are unwell
- Maximising ventilation and the use of outdoor space
- Promoting frequent hand washing and respiratory hygiene (catch it, bin it, kill it), including the continued access to hand sanitisers and paper tissues

- Continuing with enhanced cleaning schedules in the short term
- Reviewing risk assessments and considering where, over the next few weeks or months, you may wish to maintain measures that do not impact on education
- Promoting vaccination to staff and families where appropriate
- Reviewing risk assessments for any staff who are considered vulnerable
